

# NOTIFICATION OF APPLICATION FOR A NEW RESOURCE CONSENT

The following applications for resource consents have been received by the Northland Regional Council and are hereby publicly notified pursuant to sections 95A and 117 of the Resource Management Act 1991.

<b>APPLICANT:</b>	Whangarei District Council (Roading Division)

<b>LOCATION:</b>	One Tree Point Road, One Tree Point
<b>ACTIVITIES:</b>	To undertake the following activities associated with the construction and ongoing maintenance of erosion control structures in the coastal marine area:  04 – To erect erosion control structures with a total length of approximately 535 metres. This activity is a restricted coastal activity (RCA);  05 – To disturb the foreshore by extraction, contouring, and movement of foreshore material during construction;  06 – To undertake ongoing maintenance of erosion control structures that are approximately 830 metres long. This maintenance could include the use of heavy machinery within the coastal marine area. (Note: The applicant has previously been granted a coastal permit which authorises the erection of a separate erosion control structure in this area which is approximately 295 metres long and application (06) seeks to authorise the ongoing maintenance of this structure as well as the structures being applied for in application (04). Together, the total length of all the structures will be approximately 830 metres); and  07 – To erect timber beach access stairs and their occupation of space;
