NOTIFICATION OF RESOURCE CONSENT APPLICATION BY NORTHPORT LIMITED

1. We act for Northport Limited (“Northport”).
2. Northport operates a commercial deep-water port situated at Marsden Point, Whangārei.
3. Northport has identified you/your client(s) as an applicant for orders recognising customary marine title under the Marine and Coastal Area (Takutai Moana) Act 2011 (“MACA Act”) in the vicinity of Northport.
4. In accordance with the requirements set out in section 62 of the MACA Act, Northport hereby notifies you/your client(s) of Northport’s intention to apply for resource consents under section 88 of the Resource Management Act 1991.
5. Northport’s operations involve a range of activities at Marsden Point, including in the coastal marine area (“CMA”). To meet the future freight needs and support growth in Northland and North Auckland, Northport must expand. Northport intends to apply for resource consents to undertake dredging and reclamation necessary to construct and operate an expanded port footprint at Marsden Point (the “Project”). The Project will enable Northport to expand its facilities to increase its freight storage and handling capacity, including via a purpose built container terminal facility.
6. The Project includes the following:
 - (a) Reclamation within the CMA and earthworks to the immediate east of the existing reclamation to expand Northport’s footprint by approximately 13.7 hectares;
 - (b) Capital and associated maintenance dredging to enlarge and deepen the existing swing basin and to enable construction of a new wharf;
 - (c) A 250m long wharf extension to be constructed on the northern (seaward) face of the proposed reclamation;
 - (d) Construction of a new tug facility;
 - (e) Sheet piling and rock revetment structures on the eastern edge of the proposed reclamation;

- (f) Replacement of the existing public facilities including a floating pontoon, public access and a carefully designed 'pocket park' facility;
 - (g) Beach renourishment to augment a sandy flood spit feature in the intertidal area in order to create suitable avifauna roosting habitat;
 - (h) Port-related activities including a container terminal, Coastguard, biosecurity, border control/customs and quarantine facilities, harbour control facilities plus supporting offices and workshops; and
 - (i) Treatment of operational stormwater via the existing pond-based stormwater system.
