Take coastal water during dredging.4. Discharge sediment and water containing contaminants to coastal water during the dredging and disposal of dredge material.5. Deposit dredged material onto seabed within two offshore disposal areas.6. Extract dredged material from the coastal marine area (including for potential disposal to land; use in beach nourishment/reclamation).7. Relocate existing navigation aids and place new navigation aids in the coastal marine area.8. Discharge contaminants to coastal water from construction and maintenance of navigation aids.
