Offer Of Service: Cultural Impact Assessment (CIA) future development of Onoke, Kamo Whangārei

Thank you for the opportunity to provide an Offer of Service to prepare a CIA on behalf of the hapu for the proposed future development at Onoke, Kamo, Whangarei.

Please note the CIA will be prepared by Te Parawhau Hapū with members of Ngāti Kahu O Torongare contributing.

CIA Process

To ensure the Hapū understands the proposal and resultant effects on their cultural values, a number of hui (meetings) are required. An overview the anticipated hui required to facilitate the CIA process are listed below.

- 1. A hui with Hapū kaumatua including Georgina Olsen, (CIA writer/cultural RMA, environmental specialist). The purpose of this hui is to agree on the process, establish a working group (roopu kaumatua and an applicant's representative) and fully appraise the group of what the proposal entails. An online hui was held this morning.
- Three hui with Hapū members.
- 3. Roopu Kaumatua CIA review hui.

Following the CIA review, any required changes will be made. The CIA will be signed by all kaumatua and the final approved version sent to you as the applicant. Please note, communications between yourself, kaumatua and me as the CIA author will also be required.

Scope

To prepare and submit a CIA on behalf of Te Parawhau and Ngāti Kahu O Torongare Hapū (Hapū). The assessment provided in the CIA will include the following details:

- the history and hapū ūara ahurea (cultural values) in relation to the project area;
- an assessment of the various activities within the scope of the re-consenting and identification of the potential effects of these activities upon the hapū ūara ahurea;
- an assessment of the relevant legislation when considering the potential effects upon these values;
- recommendation of mitigation measures that appropriately address potential adverse effects that could inform conditions of consent and, or a side agreement with Onoke Heights Limited (the applicant).

The scope of services and associated deliverables included in the CIA are as listed above.

Provisional Sum Items

Three public hapū hui have been proposed along with participation in the working party hui (Hapū, your project team). It is not however known the level or degree of communication required by hapū. This will be charged as required and may differ to the provisional sum below.

Additionally, there is likely to be a degree of project related communications between myself, your appointed representative and hapū representatives. Provisional sum allowances for these items are provided in the table below:

Fee Schedule

- Meetings/communications are charged at \$170/hour + GST (charged from our Tutukaka office to the venue where meetings are away from my office) return.
- Mileage \$1.00/km + GST (charged from Tutukaka office to site/meeting venue) return.
- Printing as required.

Hapū Kaumatua/Kaiarahi/Kaitiaki

Whaea Mira Norris, Matua Pari Walker, Matua Benjamin Pittman, and other Te Parawhau kaumatua have been working on this project. Their time should be paid separately at the following rate (or as agreed directly with each kaumatua):

Kaumatua/Kaiarahi - \$150.00 pr hr Kaitiaki - \$75.00 pr hr

Timing

Preparation of the CIA relies on information obtained from the project documentation and meetings with hapū.

Three Hapū hui approximately 2 weeks apart are proposed. Please allow a minimum of 2-3 weeks in addition to this timeframe to prepare, send panui, arrange hui venue and catering.

The CIA can be provided approximately 4 weeks after all information has been obtained, Hapū hui have been completed, hapū whakaaro has been obtained, receipt of all documents, including a copy of the AEE and supporting plans have been received to understand the potential effects and to allow sufficient time for the hapū representatives to agree on mitigation measures, and to review and approve the final document for release.

Information required from Onoke Heights Limited

The following information is required;

- All information mentioned above including a copy of the Resource Consent Application, Assessment
 of Environmental Effects (AEE) and supporting plans and assessments.
- Onoke Heights Ltd project team will be required to present technical information and answer any
 questions should they arise at our hui.

Note: this list is not exhaustive and is subject to change as we work through the project together.

Terms

An initial deposit of 30% plus GST will be invoiced upon acceptance of this fee estimate. Full payment is required within seven days of final invoice. All debt recovery costs will be the responsibility of the debtor.

Landform Consulting reserve the right to charge interest at 2.5% above bank rates on overdue accounts. All outstanding debts will be recovered at the cost of the debtor.

This fee estimate is valid for 60 days from date of issue.

Cancellation
