Good Morning Katie,

Regarding issues surrounding navigational safety surrounding the proposed wharf.

Access to the wharf: The approaches are very shallow (We currently do not have hydrographic information covering the specific location of the wharf. We can however execute a survey if required) Use of the wharf would be tidal restricted to most if not all motorised craft. The tidal window would vary according to the size and type of vessel attempting to access the wharf. Kayaks and paddle boards may still be able to launch from the pontoon at any stage of the tide. The logistics of transporting a kayak or paddle board along the jetty or boarding craft from the pontoon falls outside of the scope of navigational safety. The observations noted regarding the confluence of tidal streams and the challenges they may or may not present to manoeuvring vessels would not constitute any remarkable or excessive hazard or risk not already experienced elsewhere. Each wharf, boat ramp, pontoon etc have their own challenges and it is the individual skippers responsibility to assess the conditions against their confidence and ability as well as the ability of their vessel to meet such – This is applicable to all water craft. With that said, the state of tide where the currents would be running the strongest would most likely fall outside of the usable tidal window of most power driven vessels, the depth of water would most likely be shallow enough to stand up in.

Enforcement: The Mangawhai Harbour and estuaries due to their sheltered nature and proximity to Auckland is an increasingly popular holiday and recreational boating destination. With its increasing popularity comes an increased demand and requirement for education and bylaw enforcement. Already there are significant challenges associated with effecting this. The upper Mangawhai Harbour being largely estuarine, is difficult to patrol due to the limited water depth and tidal windows. With the nearest vessels being based in Whangarei, lead time to deploy is approximately 1½ hours making pre planned patrols the only viable option for on water bylaw enforcement. There are two land based honorary enforcement officers located in Mangawhai who work the boat ramps educating recreational boaties, and enforcing bylaws where it is warranted and they are able to do so.
