It concludes with global submissions, other sections (where submitters made general submissions on the plan or matters not being consulted on) and surf lifesaving and GE (which received submissions). The summary is a quick reference tool for councillors and should be read in conjunction with the original submissions.

Section: Zero Rates

Submission DAP 2014/15.6 by Ms Catherine Adams

Summary: Submitter opposes council increasing rates. Funds for any development should come from (another source).

Relief Sought: Don't increase the rates

Submission DAP 2014/15.13 by Mr Billy Leonard

Summary: Submitter supports the use of investment income for core services. States that council should hold no surplus cash and should not be making investments, and should rely on rates and fees only.

Requests that rates and fees be reduced to nil until all funds are used up and Northland Inc be closed.

Relief Sought: Use investment income for core services.

Submission DAP 2014/15.16 by Northland District Health Board

Summary:

Submitter states that sustainable employment is a key issue for Northlanders, and that investing in economic development and employment is a better long term solution than subsidising rates in the short term.

Submitter raises concern that no economic development projects have yet been approved and urges the NRC to work closely with iwi in particular to address inequities in employment.

Relief Sought: Invest in economic development and employment, and address's inequities in employment.

Submission DAP 2014/15.21 by Mr Charles Randall Tutton

Summary: Submitter supports zero rates rise. **Relief Sought:** Provide for zero rates rise.

Submission DAP 2014/15.26 by Farmers of New Zealand Inc

Summary: Submitter supports a zero rate increase but not how it is achieved, and raises questions in regard to the manner in which the zero increase is being enabled.

Submitter would strongly support the introduction of a Council Controlled Trading Organisation to manage all NRC investments outside the council.

Relief Sought:

That the council consider a total review of the efficacy of Northland Inc. and how the council operates in its investment area.

That the council be removed from direct involvement in investments by setting up a CCTO. Under the appropriate Statement of Intent require this investment company to grow the portfolio for the benefit of the Council and the region.

Submission DAP 2014/15.170 by Far North District Council

Summary: Submitter is supportive of the rate reduction to close to zero for all ratepayers, as this is in line with Central Government's desire to keep rates affordable.

Relief Sought: Adopt zero rates increase.

Submission DAP 2014/15.171 by New Zealand Chambers of Commerce Northland

Summary: Submitter supports the zero rates rise, and continues to support principles for rating (outlined in submission, including UAGC, use of targeted rates etc).

Relief Sought: Adopt zero rates rise.

Submission DAP 2014/15.201 by Dive! Tutukaka

Summary: Submitter does not support a reduction in the amount of funding for economic development. States that there is a relationship between sufficient funding and the ability to achieve and succeed.

Relief Sought: Do not reduce funding for economic development.

Submission DAP 2014/15.217 by Federated Farmers of New Zealand

Summary: Rate increases as there may be should be kept in line with inflation and council's zero rates ie the reduction in rates income is, to some extent at least, being funded by the redirection of some of the income Council gains from investments. This is not sustainable in the long term. Property value rates bear no relationship to either a ratepayer's ability to pay" or to the ratepayer's use of a council service. For farmers this means a heavy tax on their key asset, land, to pay for all manner of community services, many of which they rarely if ever use. Gives 11 ideas for rating reform for all local government. (Including more/greater use of targeted rates, benchmarking etc.)

Submitter thinks council's drive to keep costs down and to not increase rates does not appear to extend to keeping the costs of resource and user fees, particularly permitted activity dairy shed effluent systems inspection fees, under tight control. Notes change in local government purpose.

Relief Sought: Tighter control on fees associated with resource consents and permitted development particularly permitted activity dairy shed effluent systems inspection fees.

That Council commit to setting its annual rate increases at levels no greater than the rate of inflation.

That Council utilise the UAGC facility and set the UAGC at the maximum level allowable under the law.

That the Council advocate to central government for meaningful reform of local government funding.

Submission DAP 2014/15.217 by Federated Farmers of New Zealand

Summary:

Federated Farmers would prefer that the nil rates increase was being delivered by the Council achieving costs reductions rather than reducing the redirection but supports the \$1M not being redirected provided Council continues its drive to keep costs down, particularly in the area of resource and user fees.

Relief Sought:

That Council use an additional \$1M of investment income to keep rates low and deliver more core services and continue to undertake development work and improvement projects in rural Northland.

Submission DAP 2014/15.227 by Mrs Margaret Hicks

Summary: Close down Northland Inc. Use council staff for assessing economic development and money saved for core business. Has searched what Northland inc is doing and believes it is all about exploiting Northland's resources. E.g. mining.

Relief Sought: Stop funding Northland inc. Use money for core business like biosecurity.

Section: Sale of leasehold investment property

Submission DAP 2014/15.4 by Mr William Higgins

Summary: Submitter supports sale of leasehold properties if council sticks to the conditions proposed.

Relief Sought: Adopt the leasehold property conditions for sale.

Submission DAP 2014/15.5 by Mr Athol Cave

Summary: Submitter supports concept of sale of Whangarei leasehold properties and diversifying portfolio across Northland because this will allow council to re-invest in areas of strategic importance and encourage existing leaseholders to do more with their property and create additional employment opportunities.

Relief Sought: Include the potential sale of leasehold properties in the Annual Plan.

Submission DAP 2014/15.9 by Spire Accountants on behalf of Konini Land Ltd

Summary: Submitter supports the proposed sale of leasehold investment properties on a discretionary basis. Submitter cites difficulty in selling leasehold properties, uncertainty for tenants, and a emerging bias to development in freehold areas.

Relief Sought: Provide for the sale of leasehold properties on a discretionary basis, as proposed.

Submission DAP 2014/15.9 by Spire Accountants on behalf of Konini Land Ltd

Summary: Submitter opposes the removal of the requirement of the original criteria that gives the current leaseholder first option to purchase. States that leaseholders have often invested in the properties and have a long-term relationship with council, and that any negotiations would be based on market value.

Relief Sought: Do not remove the requirement that the council offer current leaseholders the first option to purchase their property.

Submission DAP 2014/15.10 by Spire Chartered Accountants on behalf of Ness Properties Limited

Summary: Submitter supports the proposed sale of leasehold investment properties on a discretionary basis. Submitter cites difficulty in selling leasehold properties due to a stigma becoming attached to them, uncertainty for tenants, and a emerging bias to development in freehold areas. States that the value on these leasehold properties should be set at market value and not above.

Relief Sought: Provide for the sale of leasehold properties on a discretionary basis, as proposed, at market value.

Submission DAP 2014/15.10 by Spire Chartered Accountants on behalf of Ness Properties Limited

Summary: Submitter opposes the removal of the requirement of the original criteria that gives the current leaseholder first option to purchase. States that leaseholders have often invested in the properties and have a long-term relationship with council, and that any negotiations would be based on market value.

Relief Sought: Do not remove the requirement that the council offer current leaseholders the first option to purchase their property.

Submission DAP 2014/15.12 by Mr Glyn and Mrs Noleine Tyler Davies

Summary: Supports the proposed sale of leasehold properties.

Relief Sought: Provide for the sale of leasehold properties, as proposed.

Submission DAP 2014/15.13 by Mr Billy Leonard

Summary: Submitter supports the sale of leasehold investment properties. States that all properties should be sold, with revised conditions (detailed).

Relief Sought: Provide for the sale of all leasehold investment properties.

Submission DAP 2014/15.20 by Mrs Beverly Hopkins

Summary: Submitter states interest in purchasing leasehold property.

Relief Sought: Provide for the sale of leasehold properties.

Submission DAP 2014/15.22 by Mr Paul Anthony Gordon

Summary: Submitter supports the sale of leasehold land, and requests that leaseholders have the first option to purchase.

Relief Sought: Provide for the sale of leasehold properties, with leasee's given first option to purchase.

Submission DAP 2014/15.23 by Leith Family Trust

Summary: Submitter supports the strategic review of leasehold properties, and the identification of properties that may have future benefit or provide long term income streams for the NRC.

The submitter supports the release for sale of a particular property that they believe does not meet these requirements.

Relief Sought: Provide for the sale of leasehold properties on a discretionary basis, as proposed.

Submission DAP 2014/15.26 by Farmers of New Zealand Inc

Summary: Raises concern that commercial decisions should not be made in the political environment, and that sale or development of property should be based on sound commercial decision making not through public submission.

Relief Sought: That the Council separate its investments from the council through a CCTO governed by a professional Board that can make appropriate decisions.

Submission DAP 2014/15.29 by RRMO Ltd

Summary: Submitter supports the potential sale of council leasehold investment properties.

States that the best ownership model is for either leasor or leasee to fully own and control the leases, and that current leasing model is driving down marketability.

Relief Sought: Include the potential sale of leasehold properties in the Annual Plan.

Submission DAP 2014/15.33 by Mr Mark Workman

Summary: Submitter supports the sale of free hold on properties, citing benefits in property maintenance, business confidence, and employment. **Relief Sought:** Provide for the sale of free hold on properties.

Submission DAP 2014/15.39 by Mr Geoffery Cochrane

Summary: Submitter supports the sale of leasehold properties, and brings particualr attention to those in the Lower Dent Street area. States that leasehold land is more risky to develop and uneconomical.

Relief Sought: That the ownership of land be moved to the private sector.

Submission DAP 2014/15.81 by Mr Richard Johnson

Summary: Submitter supports the sale of 21 year leasehold investment properties with 21 year perpetually renewable leases. States that the land should be sold to the

lease only, and that this will encourage development and improvement, and free up capital for the NRC.

Relief Sought: Provide for the sale of leasehold investment properties to leaser's.

Submission DAP 2014/15.81 by Mr Richard Johnson

Summary: Submitter opposes the sale of leasehold land at, or above, market value, as the lease has a registered vested interest in the land.

Relief Sought: That council declare the amount of lease interest, in the calculated land value of council investment properties.

Submission DAP 2014/15.81 by Mr Richard Johnson

Summary: Submitter opposes selling leasehold investment properties on the open market, as proposed in the long term.

Relief Sought: Do not allow for the sale of leasehold land on the open market.

Submission DAP 2014/15.87 by Mr Desmond Cogan

Summary: Submitter states that if leasehold land is to be put up for sale, it should in the first instance be offered to the current lease holders for purchase.

Relief Sought: Allow for current lease holders to purchase any leasehold land that is put up for sale.

Submission DAP 2014/15.102 by Mr Glen Hosking

Summary: Submitter supports proposed sale of leasehold properties.

Relief Sought: Provide for the sale of leasehold properties as proposed.

Submission DAP 2014/15.162 by Mr David Lourie

Summary: Support sale if the property titles and histories are properly researched to ensure there are no treaty claims against them and Maori are consulted early to give time for research to occur. Wants all sales to be publically notified.

Relief Sought: Amend criteria to ensure property titles and histories are properly researched to ensure there are no treaty claims against them and there is public notification of sale.

Submission DAP 2014/15.171 by New Zealand Chambers of Commerce Northland

Summary: Submitter supports the proposed guidelines for free-holding Council's leasehold properties. Submitter acknowledges this process needs to be subject to a high degree of transparency and public engagement.

Relief Sought: Adopt the proposed criteria for free-holding Councils leasehold properties, and undertake the process with a high degree of transparency.

Submission DAP 2014/15.201 by Dive! Tutukaka

Summary: Submitter supports the sale of leasehold investment property.

Relief Sought: Provide for the sale of leasehold investment property.

Submission DAP 2014/15.215 by BBS Timbers Ltd

Summary: Supports the sale of leasehold investment properties, with reference to a specific property. Outlines social and economical benefits to Northland of free holding land, and discusses several other options for progressing Northland.

Relief Sought: Provide for the sale of leasehold investment properties, as proposed.

Submission DAP 2014/15.217 by Federated Farmers of New Zealand

Summary: Supports sale but notes Council should not be too concerned about the proposed future use of a building.

Relief Sought:

That Council proceed with the sale of its leasehold properties that are held for investment purposes and which do not form part of its core functions.

That the council retain the criteria for the sale of its leasehold properties, but consider reducing the reliance it places on the building or business being sold demonstrating clear economic development benefit

Submission DAP 2014/15.247 by Mr L W (Bill) Roberts

Summary: Opposes proposal to sell because it does not go far enough. Wants council sell all commercial leasehold properties because its not council's core business to operate a commercial property portfolio. The return at around 6% could be achieved with listed property companies. Also because the submitter does not know the future of the countdown Kensington property they think council does not have the connections and commercial flexibility to address a major tenant's needs (in a timely manner).

Council should not be in competition with the private sector. All property in Whangarei is a risk -what if Christchurch event happened?

All of our reviews of these properties and arbitration time and money shows we should spend time on our core functions. The market doesn't like the uncertainty associated with the lease review process. Why change our policy now and not sell if we have sold to an adjoining owner.

Recommends changes to the criteria.

Supports reinvesting in a diversified portfolio (not in direct property investment and Whangarei).

Relief Sought: Leaseholder should have first option to buy.

There should be no requirement to demonstrate clear economic benefit because the move to freehold increases the value, wealth of the region and is money in council's pocket and it can diversify investment.

Supports reinvesting in a diversified portfolio.

Submission DAP 2014/15.248 by Mr Adrian Broughton

Summary: Conditional support for the proposal the sale of leasehold properties. Deal first with existing leaseholders due to uncertainty for leaseholders if there was a new "landlord". Significant departure from historical process to not give first option to leaseholders. If the lease was transferred as is then the submitter withdraws support for the proposal. Current leasehold arrangements inhibit economic growth.

Considers sale of these properties into freehold title will unlock significant value and opportunity to the region. Historic reason for ownership of property (as harbour board and for council Harbour functions) no longer exists. Council investor and landlord functions have not been performed well.

Relief Sought: Change criteria to deal first with existing leaseholders

Section: Fees and charges

Submission DAP 2014/15.25 by Mr Dave Roke

Summary: Submitter notes a reference to 'restricted coastal activities' (Draft Charging Policy, Appendix 1, Note 6), and notes that all reference to 'restricted coastal activities' was removed from the Regional Coastal Plan in 2010 (relevant NRC resolution included to submission).

Relief Sought: That Note 6 on page 134 of the Draft Annual Plan be deleted as it is no longer relevant.

Submission DAP 2014/15.26 by Farmers of New Zealand Inc

Summary: Submitter opposes policy of setting charges based on inflation. States that increasing fees based on a national average of monopoly service providers or the CPI does not reflect the true or actual costs.

Relief Sought:

That the council have an accurate understanding of its cost structure and determine its level of efficiency like any organisation in the private sector.

Submission DAP 2014/15.217 by Federated Farmers of New Zealand

Summary: Supports inspection and ensuring stringent level of farm dairy effluent monitoring but concerned about fee increases particularly since 2009. States proposed \$171 is an increase of some 4.3% at a time when annual inflation is very low, 2.4% overall in the two years March 2012 –March 2014.

Relief Sought:

That the Council use its best endeavours to ensure farm dairy effluent monitoring charges are kept as low as possible, and in particular that they are kept affordable.

Section: Maori Committee

Submission DAP 2014/15.7 by Mr R P Chapple

Summary: Submitter does not support the Te Taitokerau Regional Maori Advisory Committee because:

i) there is no such thing as a 'real' Maori
ii) the Treaty of Waitangi did not form a sovereignty partnership, it was a treaty of cessation, and
iii) all citizens are equal
iv) consultation with Maori as manawhenua is wrong given most land has been sold into private ownership.

Relief Sought: Remove reference to the committee and Maori.

Submission DAP 2014/15.16 by Northland District Health Board

Summary: Submitter supports improved partnerships between iwi/hapu and the NRC through the Te Tai Tokerau Regional Maori Advisory Committee.

Relief Sought: Continue to provide for improved partnerships through the Te Tai Tokerau Regional Maori Advisory Committee.

Submission DAP 2014/15.19 by Mr Thomas and Mrs Beate Lauterbach

Summary: Submitter supports the NRC's proposal to foster stronger ties with Taitokerau mana whenua/tangata whenua by creating the Te Tai tokerau Regional Maori Advisory committee.

Submitter requests that support and respect be shown for the precautionary and prohibitive GE policies of all Taitokerau lwi authorities for their respective rohe.

Relief Sought: That the Te Tai Tokerau Regional Maori Advisory Committee be provided for and that support and respect be shown for the precautionary and prohibitive GE policies of all Taitokerau Iwi authorities for their respective rohe.

Submission DAP 2014/15.26 by Farmers of New Zealand Inc

Summary: Submitter opposes the introduction of a Maori Advisory Committee. Raises concern that this would compromise the basic tenant of the rule of law requiring all to be treated equally.

Submitter suggests that if the Council had real concern for those facing economic and social hardship it would consider economic well-being a core issue and act accordingly.

Relief Sought: No specific relief sought.

Submission DAP 2014/15.134 by Mr Rolf Mueller Glodde

Summary: Submitter supports the proposal to foster stronger ties with Taitokerau mana whenua/tangata whenua by creating the Te Taitokerau Regional Maori Advisory committee.

Relief Sought: Provide for the Te Taitokerau Regional Maori Advisory committee.

Submission DAP 2014/15.146 by Ms Shushila Ajani

Summary: Submitter supports the proposal to foster stronger ties with Taitokerau mana whenua/tangata whenua by creating the Te Taitokerau Regional Maori Advisory committee.

Relief Sought: Provide for the Te Taitokerau Regional Maori Advisory committee.

Submission DAP 2014/15.162 by Mr David Lourie

Summary: Conditional support for the Te Taitokerau Regional Maori Advisory Committee on the basis that the committee mush achieve real outcomes that benefit tangata whenua.

Relief Sought: Establish Te Taitokerau Regional Maori Advisory Committee

Submission DAP 2014/15.170 by Far North District Council

Summary: Submitter supports the improvement of relationships with maori across all of local government, however raises concern that these structures must not impede the relationship with any one Council or make it more difficult both in capacity and capability for Maori to work regionally with all Councils.

Relief Sought: would like council to work with FNDC and all Northland Councils to develop a model that works both for Maori within all levels of local government in the Northland region

Summary: Submitter supports the Te Taitokerau Regional Maori Advisory Committee initiative

Relief Sought: That Council progress work on the Te Taitokerau Regional Maori Advisory Committee initiative.

Submission DAP 2014/15.225 by Ms Zelka Linda Grammer and Family

Summary: Supports new committee

Relief Sought: Establish committee

Submission DAP 2014/15.239 by Ms Beverley Gott

Summary: Supports Te Taitokerau Regional Maori Advisory Committee

Relief Sought: Set up Te Taitokerau Regional Maori Advisory Committee

Section: Waiora Northland Water

DAP 2014/15.15.2 in Submission DAP 2014/15.15 by Mr Alan W Agnew

Summary: Submitter does not support the fencing of all bush creeks and rivers. States that fencing can cause weed build-up which has associated issues, and that stock can keep weed growth down. Submitter suggests that farmers be encouraged to have more water troughs, and where necessary construct concrete fords across waterways.

Relief Sought: While the submitter does not specifically state the relief sought, it is inferred that relief sought is: Provide for consideration of alternatives to fencing all bush creeks and rivers.

Submission DAP 2014/15.16 by Northland District Health Board

Summary:

Submitter supports the aims of Waiora Northland water, and the increased investment in monitoring.

Submitter urges a more rapid response to the freshwater degradation of Northland catchments.

Relief Sought: Provide for the Waiora Northland water programme as proposed, and include a more rapid response to freshwater degradation.

Submission DAP 2014/15.24 by Mr Tony Foster

Summary: Submitter supports a stronger commitment to improving water and river quality.

Relief Sought: That punitive action be taken against farmers who do not fence rivers and allow animals in waterways.

DAP 2014/15.150.1 in Submission DAP 2014/15.150 by Environment River Patrol

Summary: Submitter raises concern in regard to sediment problems in the Wairua/Wairoa rivers, and the Whangarei Harbour, and that unfenced beef cattle in both catchments, and diary stock with access to smaller creeks and drains, contribute in a major way to the sediment problem.

Raises concern in regard to reporting and monitoring of fencing on the riparian of waterways. Raises concern in regard to stock effluent disposal in waterways.

Submitter raises concern that an increase in Primary Industries production may be led by intensification of beef and dairy farming, which may involve the breaking in of the last lands that give sustainability to manu and the threatened bee industry, and may result in more critical losses to the biodiversity of nature and more degraded waterways. Supporting documentation attached to submission.

Relief Sought:

That NRC

• provides independent contract assessors to assess the requirements of 'stock exclusion fencing and margins' to dairy farms.

- adopts same dairy fencing policy for beef cattle farms in dairy regions ie. sign beef farmers into the same accord as dairy farmers.
- adopts an 'industry standard, stock exclusion fencing code' that covers post, wire, temporary fence, riparian margins etc.
- changes water testing distance from 20 metres from POD to 10 metres for dairy farms discharging to water.
- creates an emphasis on the actual POD (of dairy farms) and determines a criteria measure of the particular effluent pond system's performance to ensure it is 'fit for purpose' and not relying on the 'wash away effect' when it enters larger waters.

Submission DAP 2014/15.162 by Mr David Lourie

Summary: Supports the extra \$165,000 funding for the Waiora Northland Water monitoring programme and improving the quality of water. Wants cost effect regulation to allow farmers, foresters, industry, urban dwellers and district councils to adopt sound catchment management practices.

Relief Sought: Retain extra \$165,000 funding for the Waiora Northland Water monitoring programme

Submission DAP 2014/15.171 by New Zealand Chambers of Commerce Northland

Summary: Submitter acknowledges the regions vulnerability to drought and the risks that unavailability of water could pose to inward investment.

Submitter supports Waiora Northland Water as an initiative.

Relief Sought: That the NRC continue to work with the district councils to develop region-wide strategies to safeguard Northland against future water shortages and to implement good management practice.

Submission DAP 2014/15.202 by Kaipara District Council

Summary: Submitter supports the primary objective of the programme and working with industry on good management practices, landowners and community groups through the E Fund.

Relief Sought: Wants kai iwi lakes identified as a priority one catchment and council to work on the Kaipara Harbour catchment despite it being priority 2 and poutu work to continue over the 2014/15 financial year.

Submission DAP 2014/15.216 by Fonterra Co-operative Group Limited

Summary: Fonterra supports the additional 165k for environmental monitoring stating that 'good information underpins good decision-making'. Also support collaborative process with a view to plan changes by 2015.

Relief Sought: Keep the additional 165k

Submission DAP 2014/15.218 by Mrs Fiona King

Summary: Supports Waiora Northland Water programme and river management committee.

Relief Sought: Continue with improvements to the Awanui flood scheme.

Submission DAP 2014/15.227 by Mrs Margaret Hicks

Summary: Supports the project. Notes relationship between sediment control and flood risk and bank erosion. wants nutrient run off reduced. Mangroves are an effect of poor management of our catchments.

Relief Sought: Mandatory riparian fencing and planting of waterways. Enact bylaws for this. Introduce regulation for nutrient run off and land clearance and forestry. Improve flood control through clearing debris from streams.

Summary: Supports additional water monitoring and spending of \$165,000.Would like council to monitor changes in sediment and nutrients in areas where work is being done by landowners and community groups to try to reduce sediment and nutrients reaching waterways.

Summary: Supports the increase.

Relief Sought: Retain the increase.
