'Task List'

- An initial 'Task List' was provided by Mr Williamson and Ms
 Letica in a Memorandum to Commissioners dated 4 September
 2020. Task 6 on that list stated "Potential Wetlands Risk
 Analysis".
- 3. To that List, the Commissioners in their in their Direction #2 (paragraph 4), added some other tasks.
- 4. The Commissioners also stated:
 - "... in consultation with the Department of Conservation and the Northland Regional Council to prepare and submit a jointly agreed schedule of tasks and a timeline for that work for our agreement by no later than Monday, 28 September 2020. We also invite those persons to advise and identify whether all or some of that work could be completed as part of an adaptive management set of conditions."

Task 6 (Wetlands)

5. The Commissioners Direction #3, related particularly to Task 6 (wetlands analysis). DOC technical experts have been involved in expert conferencing in relation to Task 6. The Joint Witness Statement dated 22 September 2020 has been filed accordingly (signed by DOC technical experts).

Wider Task List

6. DOC queried what was occurring with the wider task list. As no further engagement was identified for this matter, DOC was

then surprised to receive Statement of Supplementary Evidence of Mr J Williamson on 28 September 2020, not only adopting Mr Williamson's (and Commissioners) tasks but also addressing them substantively. Unfortunately, DOC has not been consulted on this wider set of tasks. Counsel addresses a way forward below.

Planning conferencing

7. The Commissioners Direction #3 stated the following in relation to planning involvement:

[5(b)] When that plan is sufficiently developed², planners for those parties are to confer to determine whether, in their opinion, the plan is sufficient for the purpose outlined in paragraph 4 above³, or could be with further indicated refinement, and advise the Panel accordingly.

[5(c)] Progress toward that end should be advised as part of the jointly agreed schedule of tasks and timeline required by paragraph 6 of Minute and

8. DOC queried what was occurring with this planning involvement.⁴ Naturally DOC was keen to be involved. DOC was advised at short notice that the planners were to conference on the same day as the technical experts (22 September). DOC advised that DOC's planner could not attend on that particular day. DOC was assured that the planners in attendance (Ms Letica and Ms Kane) would be silent observers only and that the planning conferencing directed by Minute #3 at paragraph 5(b) would not occur on that day.⁵

9. DOC was then surprised to receive (yesterday) a letter that purports to be an Expert Conferencing statement between NRC Consultant Planner and Applicant's Consultant Planner on this very matter. It is gratifying that Ms Letica and Ms Kane agree with the proposed next steps and have signalled that incorporation into the GMCP can occur. DOC has not agreed to this. At this time, it is premature to comment on whether incorporation into the GMCP is going to be acceptable to DOC.

Steps

- 10. DOC is now working through the Supplementary Statement of evidence provided by Mr Williamson (dated 28 September) and anticipates being able to provide a response on the adequacy of the wider task list Tasks, within 5 working days (by 6 October 2020).
- 11. If further planning conferencing is to occur, DOC's planning expert would appreciate having the opportunity to be involved. The current approach does not appear to be collaborative. DOC does not agree with the assumption that "once a short list has been established and agreed upon, conditions and measures in the GMCP's can then be developed to formalise specific monitoring requirements and adaptive management responses".
