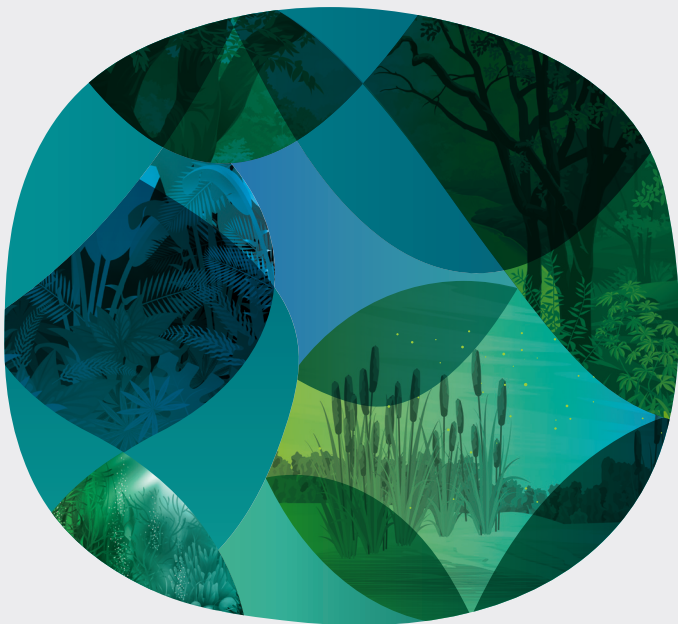

FEEDBACK ON THE DRAFT FRESHWATER PLAN CHANGE

He kōrero whakahokia mō te panonitanga hukihuki o te Mahere Wai māori

Thanks to everyone who provided feedback on the draft Freshwater Plan Change. We received 577 responses representing a range of views.

The next version of the plan will be a proposed plan. You'll be able to make a submission on the proposed plan and present your views at a hearing.

The government has extended the timeframe for this part of the process, and we now have until 2027 to complete the next version of the plan. Over this time, the Government will be making changes to national freshwater policy and we won't be completing the next version of the plan until the national policy direction is clear.

YOUR RATES AT WORK

COUNCIL SERVICES

Funds activities including planning, consents and monitoring; governance and engagement; economic development; customer services, transport, harbour safety and oil pollution control; corporate services and other activities.

LAND AND FRESHWATER MANAGEMENT

Funds land management activities and activities to improve freshwater quality in local waterways, like erosion control, landowner advice, water quality monitoring and water allocation.

PEST MANAGEMENT

Funds pest plant and animal management activities on land and in the water and supports community-led pest control projects.

FLOOD INFRASTRUCTURE

Funds the development of flood protection infrastructure and other minor river works.

EMERGENCY AND HAZARD MANAGEMENT

REGIONAL SPORTING FACILITIES

Contributes towards development of sporting facilities of regional benefit.

Funds activities which support economic wellbeing in Northland and community infrastructure.

Ngā Karahipi Tū i te Ora

Six Northland students will receive \$4000 financial assistance and paid work experience from Nov 2024 - Feb 2025 thanks to our fifth Tū i te ora Scholarships.

The annual scholarships – which your rates help pay for – recognise, encourage, and support students to undertake study, research or training that relates to council's environmental and regulatory functions. They also aim to build Māori capacity within Te Taitokerau, with three of the six scholarships earmarked for Māori who whakapapa to Te Taitokerau.
