I am writing this letter on behalf of the Far North District Council (FNDC), who are currently in the process of preparing applications to renew the existing resource consents for the East Coast Bays Wastewater Treatment Plant. FNDC has commissioned our company to prepare and lodge the applications with the Northland Regional Council.

The existing resource consent was issued in August 2001 and expires on 30 November 2008, thus an application for renewal of this consent is necessary.

During the application process, we would like to consult with you, to give you some general information about the project and consent application, to seek your input/feedback and to extend an invitation for you to contact us if you would like to discuss any issues or would like further information.

The existing wastewater treatment plant is located west of the Taipa Township. The East Coast Bays Wastewater Treatment Plant consists of two aerated ponds followed by a maturation pond. Treated wastewater is then pumped to a four cell constructed wetland prior to discharge to a tributary of the Parapara Stream.

The volume of wastewater discharged is currently set at 1005 cubic metres per day (based on dry weather flow). The application for renewal requests that this flow rate be increased to 1570 cubic metres per day. This will allow for growth up to year 2033.
