3 Matters considered at Conferencing – Agenda and Outcomes

3.1 Historic calibration information related to modelling

Richard Reinen-Hamill is preparing a supplementary statement of evidence to address the model validation questions and his commentary on the effects of sea level rise raised by Karin Bryan. In the interim, Richard Reinen-Hamill will provide to Karin Bryan, Craig Davis and Doug Treloar with the 2017 report from MetOcean Solutions covering the establishment of numerical models of wind, waves, currents and sediment dynamics prepared for Refining New Zealand.

3.2 Effects on Channel Infrastructure import terminal

Effects on Channel Infrastructure were not addressed in conferencing as the Channel Infrastructure coastal processes expert was not present.

3.3 Cumulative effects of dredging with current dredging programmes

Brett Hood advised that he understood the concern raised related to simultaneous dredging by Channel Infrastructure and Northport. This is a matter addressed in proposed conditions (Condition 117 – Brett Hood's evidence version dated 25 August 2023). Doug Treloar and Richard Reinen-Hamill concur with the inclusion of the condition.

3.4 Coastal process effects relating to the proposed bird roost and Marsden Bay shoreline, marina channel and Blacksmiths Creek

Craig Davis and David Lamason confirm that the concerns raised by the submitter (Marsden Cove Limited and Marsden Cove Canals Management Limited) is related to the potential implications of the additional supply of sand from the proposed bird roost for the Marsden Cove channel dredging and Blacksmith Creek flowpath diversion consent. They are not satisfied that the proposed conditions which provide for monitoring and adaptive renourishment will adequately address their concerns (Brett Hood's 25 August 2023 conditions 189-195 and 10), noting that the conditions do not provide for any specific follow-up remedy if an adverse effect is identified, further noting that decreasing sand top-up to address adverse effects may reduce the performance of the bird roost. Their preference is for an alternative bird roost location outside of Marsden Bay.

David Lamason considers that further detail specifications relating to the bird roost (as recommended in the coastal process report) be included in proposed Conditions 42-46 and that there be cross-referencing with Conditions 189-195.

Richard Reinen-Hamill agrees with the recommendations set out in Doug Treloar's technical memo (s42a report Appendix C1) regarding the sandbank renourishment area and geological monitoring and maintenance. The issue not addressed in the conditions is the monitoring following a significant storm event. He agrees that the conditions do not specifically set out a follow-up remedy other than in the general review condition (Condition 10).

The experts for Northport confirm that they will take the concerns expressed under this section 3.4 into account in preparing the next version of the proposed conditions.

3.5 Sea level rise
