Recent (2010-11) projects

Research: On behalf of a community activist group I have analysed a sample of rating levels across the Far North District Council to measure the inverse care law as it applies to local body economics.

Teaching

I prepared for the School of Environment a research project on the issues of conducting research on a SIDS intervention in the community setting which I presented to GEOG 305 (Population, Health & Society) in September, 2010. The presentation included a self-made DVD documentary which is now available in the University's a/v library.

I prepared for the School of Environment research on engineering and economic aspects of Hokianga sewage treatment issues in connection with an appeal to the environment court on behalf of Te Mauri o te. Since June 2011 I have produced (and been the junior editor) a feature-length documentary focused on Hokianga. The film showed in the NZIFF in July 2014 and in theatres and on Maori TV. Available on Youtube as Tumanako/Hope

I am currently part of the Community Liaison Group, Te Mauri o te Wai, mandated by the Environment Court to collaborate with the FNDC on bringing the Rawene Sewage Treatment facility into compliance with regional standards.

My current research (2015) s a personal project on Psyche and Landscape. It involves understanding the place of wilderness, mountains, lakes and forests in the psyche. That of course implies looking at psychic health with respect to these features. The project is in an early stage. It is the one for which I am using the library resources available through the University.
