- My name is Herbert Ross Familton. I have been employed in the position of Resource Management Planner since 21 May 2012 by the Department of Conservation (DOC).
- 2. In my current role, I am responsible for providing professional Resource Management Act (RMA) planning information, advice, and analysis on resource management issues for plan and consent hearings and appeals on behalf the Director-General of Conservation.
